## $Section \ 4-Identity \ and \ Statement \ of \ Educational \ Purpose$

#### To Be Signed at the Institution

The student must appear in person at Pepperdine University to verify his or her identity by presenting an unexpired valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport.
